- Budget is crucial for delivering any actions if it's not in the annual budget, it won't happen

- Absence of links with Academia

  - All SPCs should include Biodiversity in their discussions

## What are the internal barriers to implementing existing and new actions to protect and enhance biodiversity?

- General lack of awareness of the Biodiversity Plans
- Very low implementation in some cases
- Lack of ambition in some plans
- Heritage and Biodiversity Officers aren't really a part of the council decision-making structures
- Absence of Biodiversity Officers
- Heritage Officer role is too broad
- Poor national leadership means the local authorities are limited in their ability to act
- Biodiversity is a niche interest in many local authorities
- Biodiversity Plans are under pressure from the drive for local development, and the relationship between the Councillors and the heritage officers and Planning Dept needs to be good
- Serious lack of budget for biodiversity
- Land ownership
- Lack of awareness of elected councillors re the legislation
- SPCs
  - o as a mechanism doesn't really work.
  - Too few meetings
  - Poor scheduling leads to absence of other sector reps
- Lack of collaboration between NGOs, farmers etc
- Lack of contact with nature
- Lack of ambition regarding Biodiversity actions which is likely to be linked to lack of staff/financial resources/knowledge
- Need MEPs to alert local authorities to EU funding streams
- Poor information leading to poor decisions that then have to be undone
- Ignorance re spraying
- Removing herbicides leads to increased management costs
- Absence of joined up thinking. Directors of Services silo thinking
- Access to data for land owned by LA
- Red tape can prevent ideas being implemented
- Training of Councillors
- EU funding applications require huge time resources
- National Development Plan (NDP) fails to focus on biodiversity
- The term biodiversity- doesn't always connect with people. Preferable to use nature & wildlife.
- Shifting baseline syndrome- people can only empathise with loss of species and habitats that were familiar to them in their youth. The range decreases with every generation.
- Level of awareness in the Council Chamber.
- Gross under-resourcing of the NPWS

- Perceived lack of power of Elected Members to make decisions compared with relative perceived power of City County Managers Association (CCMA)
- National roads legislation undermines biodiversity protection
- Misunderstandings regarding the hedgerow cutting legislation.
- Sitka Spruce Plantations
- An Bord Pleanala are not interested in Biodiversity
- Strategic Infrastructure Act has undermined local democracy
